

Dear Saliha,

We refer to the above matter.

It was reported by the Insured that he rear-ended TP vehicle. The impact caused his vehicle to swerved left and was collided by another vehicle travelling along the left lane. Please see below OI sketch plan.

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling along PIE on lane 1, the front vehicle 522 541A was braking intermittently before braking hard. As a result I could not brake in time and hit the front vehicle rear left and my vehicle on the right front. Then vehicle shifted to the left and was hit by an oncoming vehicle on lane 2. As a result, north coming 3 vehicles were involved in the accident. My vehicle was badly damaged on both front wheels and the vehicle was towed to Beraco Motors.

We are of the view that BOLA 28(j) may be applicable where our Insured could be liable to both vehicles and a possible 2 TP claims against him.
