We refer to the above matter.

Third party reported that he stopped at the traffic light as the light was red. When the traffic light turned green, third party moved off slowly and our insured cut into his lane. Thus the accident happened.

Insured driver reported that he was stationary side by side with third party as the traffic light was red. When the traffic light turned green, insured driver noticed that third party was not moving. Therefore, insured driver signaled left, moved forward & switch lane in front of third party. At this moment, third party had moved forward and hit onto our insured vehicle.
