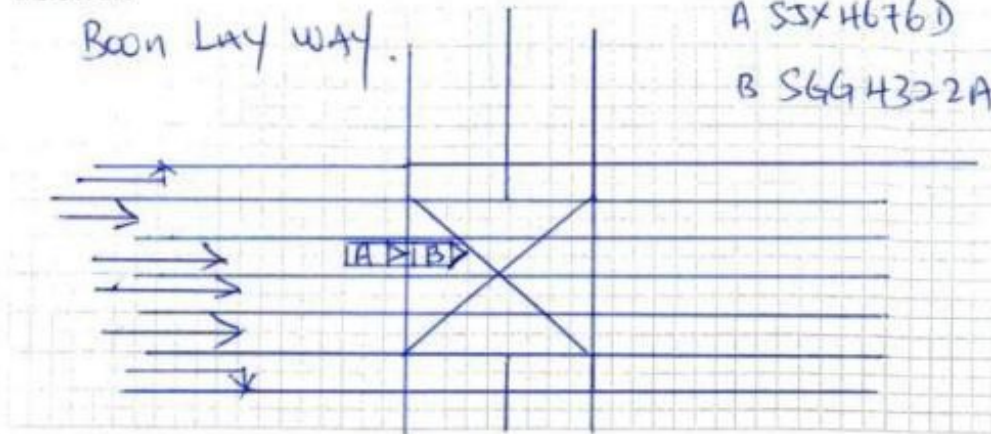
Accident Sketch Plan

Boon Lay way.

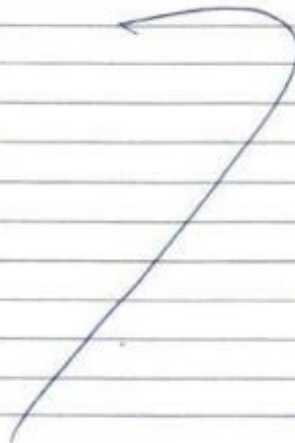
