Accident Sketch Plan

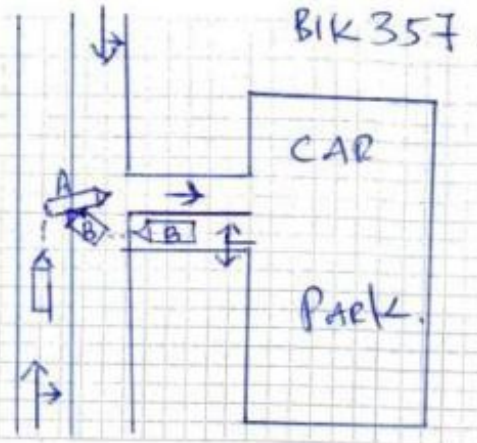
