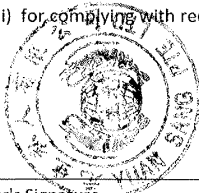

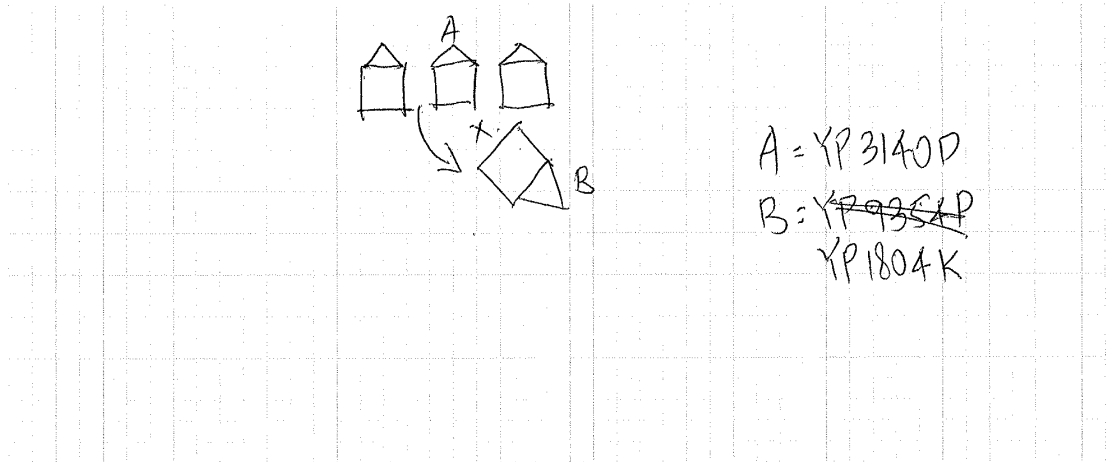

SKETCH PLAN



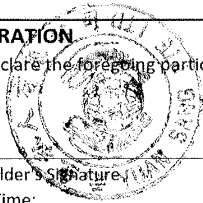
