SKETCH PLAN

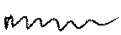

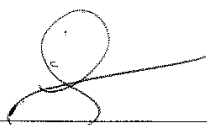

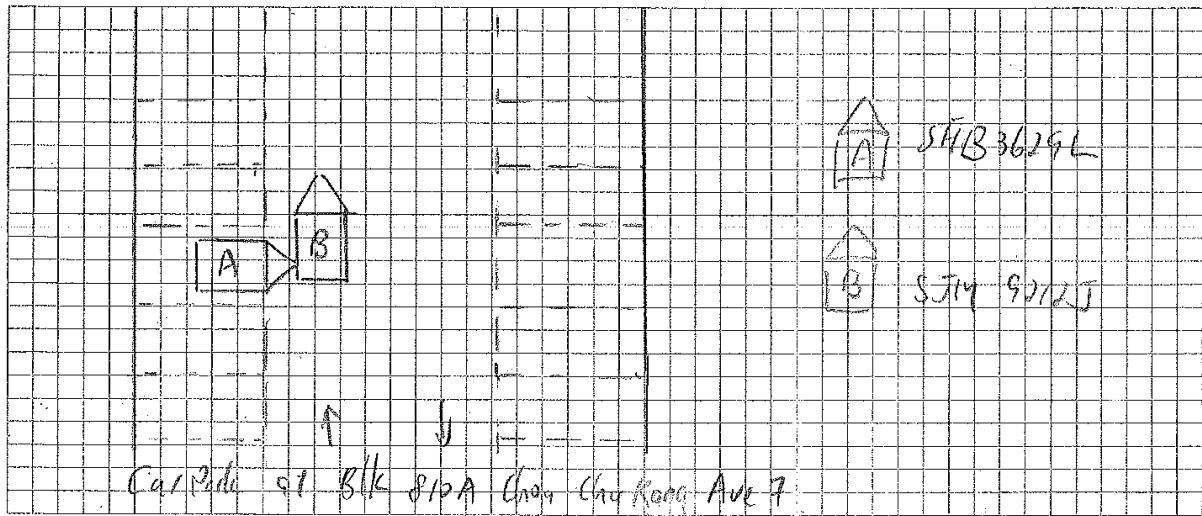
