**Brief Details.**

On 18/03/2020 at about 1700hrs, I commenced my part-time job as a Grab Deliveryman using my own motorbike bearing registration number FBM1649E. At about 1750hrs, I had picked up orders from NEX Shopping Centre and my destination of delivery is at B/142 Bishan St 12. At about 1810hrs, I was riding along the extreme right lane of Bishan St 13. I then stopped at the junction of Bishan St 13 and Bishan St 11 as the traffic light was red. There is one white colour car in front of my motorbike. Both the white car and myself had inches out slowly.

The next moment, I felt an impact coming from the rear of my motorbike. I immediately pressed my brakes in order not for my bike to move forward. As the impact is too much, my motorbike had collided abit onto the rear side of the white car. Neither myself nor my motorbike fell onto the ground. The driver of the car that hit my motorbike came out and enquired with me if I needed any medical attention. I told him that I do not required any immediately medical treatment. Both of us then managed to exchange particulars and we took photos.

I then went to private clinic for medical treatment and was given 03 days of MC by the doctor as I suffered pain on both my back and right wrist.
