When my bus was passing by the slip road, the private car just exited out. At this juncture, there was a lorry passing by on my right. I could not swerve right and i noticed from my left side mirror the private car right front portion had grazed against the left center portion of my bus..Therev were 2 pax onboard my bus and no injuries were reported. My bus sustained left center body scratches and dented. That's all.

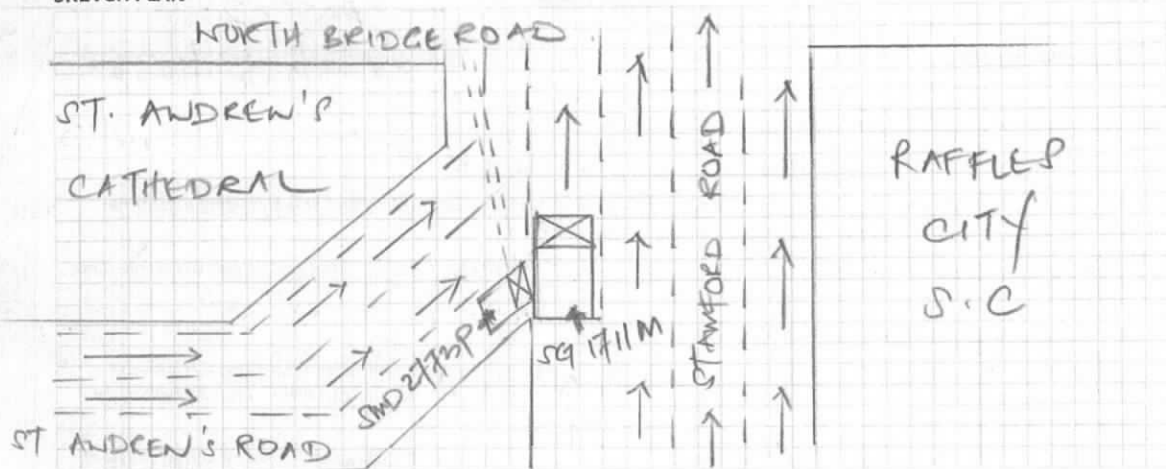
