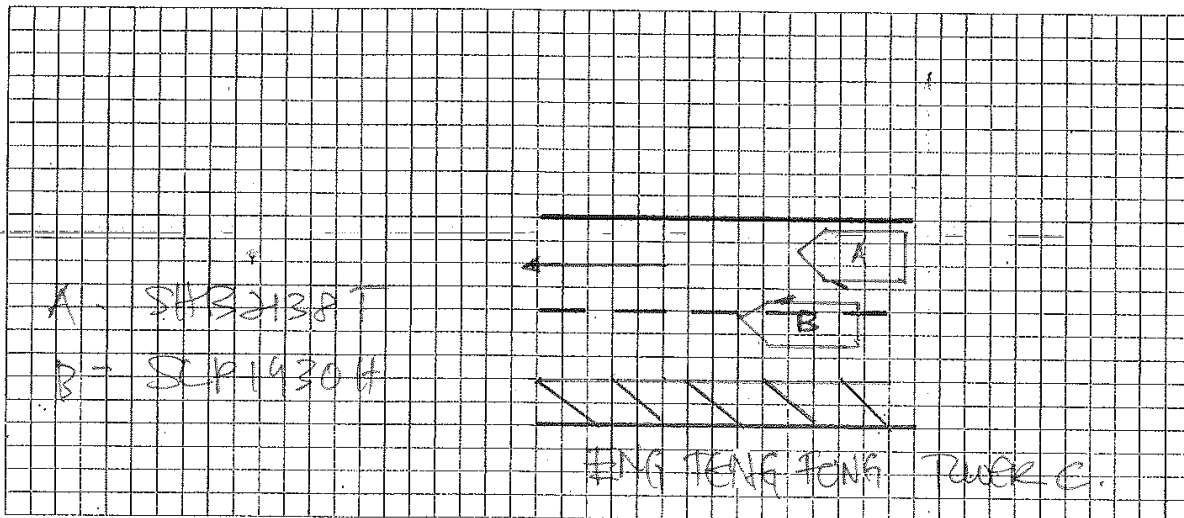

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 17/3/2020 ABOUT 21:55HOURS I DRIVING MY TAXI (SHB2138T) ALONG ENG TENG FONG HOSPITAL. I WANTED TO GO TAXI STAND. WHILE DRIVING JUST AT TOWER C, I VEHICLE BLOCKING WAY, THE DRIVER PARKED HIS CAR BETWEEN 2 LANE AND BLOCKING WAY FOR N-COMING VEHICLE. DUE TO THE BLOCKING I SLOWLY MOVING BUT THE VEHICLE TOO CLOSER AND BOTH SIDE MIRROR CRASHED. THEREAFTER I WENT CHECK, MY TAXI MIRROR WAS NOT DAMAGED AND THE OTHER VEHICLE HIS R/S SIDE MIRROR DAMAGED. THIS ACCIDENT HAPPENED BECAUSE THE NEGLIGENCE OF OTHER DRIVER WHICH IMPROPER PARKING. THE OTHER VEHICLE BEARING PLATE (SLP1930H).
