ON THE STATED DATE AND TIME, MY LORRY (YN2549B) WAS PARKED ALONG LOYANG WAY (LEFT LANE ALONGSIDE 30 LOYANG WAY JTC FACTORY). I JUST TURNED AND LOOKED OUT OF THE WINDOW, CHECKED NO TRAFFIC AND OPENED THE DOOR AND CAME DOWN OF THE VEHICLE SLOWLY AS USUAL, HOLDING THE SIDE RAIL BECAUSE THE LORRY IS HIGH. THE TRAFFIC WAS LIGHT AT THAT TIME. SUDDENLY I FELT AN IMPACT AND SAW A BUS (VEHICLE B - PD512D) BESIDE ME. THE BUS SIDE MIRROR HIT AGAINST MY DOOR AND CAUSED DAMAGES ON IT. WE ARE CLAIMING ALL REPAIR COSTS AND LOSS OF USAGE OR RENTAL OF VEHICLE AGAINST PD512D. THE WEATHER WAS DRY AND NO ONE WAS INJURED.

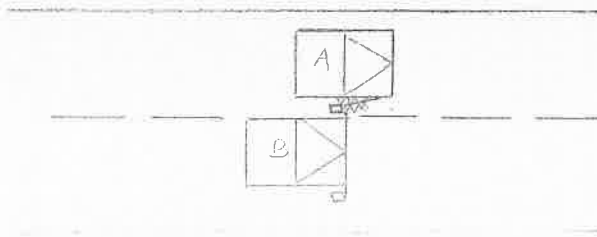
