

- On the said date and time, above mentioned informant was deployed for CVE team 10 together with team member PC (APF) T10916 Eddie Chin Yi Ther ( Guardsman ) and LCP (APF) T11419 Chong Siew Yin ( Transaction Officer were performing cash & valuable escort utilizing CIT vehicle GBH2665T.
- Upon completing last assignments at DBS Ang Mo Kio Central, the team then left the location and proceed Brinks Tai Seng CPC to return the valuables
- 3. Before the collision, AETOS Vehicle GBE 2665T was stationary at Lane 3 of 5 on a go straight or turn right lane and the third-party taxi was stationary at lane 4 on ONLY go straight lane. Both vehicles were side by side while waiting for the traffic light to turn green. Upon traffic light indication turn green the third-party Taxi attempt to switch the lane without looking at oncoming vehicle which resulted collided into AETOS vehicle GBE 2665T. Once traffic light turned green, Informant slowly accelerate AETOS vehicle to move forward and he immediately stop the vehicle when heard friction sound coming from the left side of AETOS vehicle.
- 4. The team immediately alighted from the vehicle and checked the condition of both vehicle. Found minor scratches on the left front bumper of vehicle GBE2665T and the right door of the 3<sup>rd</sup> party vehicle SHC5980C.
  - PC (APF) T10916 Eddie Chin reported the details of the accident to SSGT (APF) 9216 Ng Guet Lu then the case Was escalated to OC Insp Gideon.
- 5. No one was injured in this accident.




