He was given one Hyundai Avante/SJP6514S and the rental fee for it is \$45/- and the deposit is \$100/-, as such he was required to pay an amount of \$145/- which he would usually make the payment via bank transfer however for the said day, he informed that he had some problem with his bank account and he will be paying cash when he collects the car however I told him that there will be nobody to collect the money as it is the workshop and they are not my staff. I then suggested for him to deposit the cash via ATM machine to my account and also provided him with my bank account but he did not do so till date.

On the same day at about 6pm, I was informed by the customer that he had met with an accident with one Honda/SLT2684R and both of them agreed to settle the matter privately as such, they will not be making any reports and I then asked him to come to the workshop together with the other driver on 21/03/2020 at 1pm for us to check on the damages and also adviced him to lodge a report. Later that day at about 6.55pm, the other driver whom he met with an accident with informed my customer that he had lodged a report with his insurance.

On 21/03/2020, I reminded him to transfer the rental fee of \$145/- and another \$500/- for deposit as he had met with an accident. My boss waited for him at the workshop until 3pm but he did not turn up. I then tried calling him but he did not answer. On the same day at about 4pm, he informed that he will be returning the vehicle today. I then told him to update me when he is at the workshop to return the vehicle so that I can be there to access the damage and do up a report for the accident. However, he only updated me that he had dropped off the vehicle at 10pm, that day and he is going overseas.

Since then, he is uncontactable and he has yet to pay the rental fee of \$145/- and in the contract also
