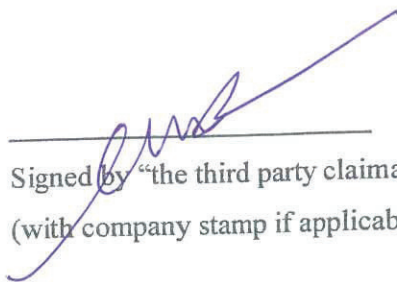
AUTHORISATION TO ACT

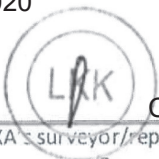
