Circumstances Of Accident #straightroad Accident_Scenario Changing lane & Description On the 6th March 2020 (Friday evening) at around 18.40pm I drove my vehicle (SDH8381H) exiting out from ION Orchard toward Orchard Boulevard driving slowly into the 2 lanes yellow boxes (see Blue Arrow). The traffic at that time was very heavy. After passing the 2nd yellow box and viewing my left side to ensure that there was no approaching vehicle from the 3rd lane I turn right onto the 3rd lane with my left signal light on. I again view my left side again to make sure there is no approaching vehicle from the 4th lane and move slowly to filter to the 4th lane with my signal light still on. My vehicle had entered half of the 4th lane when suddenly a vehicle (SMJ1452R) approached fairly fast on my left side. I applied brake and slowed down but the other vehicle (SMJ1452R) moved forward and collided its right rear side onto my left front corner on my vehicle (SHD8381H). I could not sway to my right to avoid a collision as there was an approaching vehicle on my right. My vehicle (SDH8381H) was in front of the other vehicle (SMJ1452R) before the accident happened. 


