Brief Details.

On 31st March 2020, at 7:45 pm, I was driving in the middle lane, second lane from the right, along Yio Chu Kang Road towards Serangoon Central with my front seat passenger Philip Tan Tai Lek and rear seat passenger Woon Seng Huat Jeffrey, when a vehicle SDU8908X came from the right and collided with my vehicle SGK1177B before Parkwood Residences. After the incident as we came to a brief stop at the traffic light pedestrian crossing, when Mr Woon and I signalled to the driver of SDU8909X to pull over to the right side of Yio Chu Kang Road to discuss about the incident but instead the driver of SDU8908X gestured apologetically and started to drive ahead.

At the second traffic junction, Yio Chu Kang Road and Serangoon North Ave 1, SDU8909X abruptly signal right and turned into Serangoon North Ave 1. As I was 2 lanes away from the right turning lane and there were several vehicles starting to move when the traffic light turned green, continue to forward to look for the next U-turn. After which I went pass Serangoon North Ave 1 but could not find the vehicle SDU8908X.

The incident have damaged the front right side and driver door of SGK1177B. With several alarms indicator lighted up on the dashboard of SGK1177B.
