**Brief Details.**

On 07/04/2020 @1240hrs, I was driving my car (SLC5792G) along Jurong West Ave 2 and was travelling on lane 4. I had stopped at the traffic light cross-junction of Jurong West Ave 2 and Jurong West Ave 4 because of 'red' light. Suddenly I felt an impact coming from the rear of my vehicle and I realized that a m/taxi (SHD3135J) had hit onto the rear of my car. As no one was injured at that point in time, we exchanged particulars and decided to proceed with insurance claiming. A while later I felt pain on my neck, back of body and my right hand. I then seek medical treatment at Mount Alvernia Hospital and was given 5 days of medical leave. My car rear bumper dented and cracked due to the accident.


