**Brief Details.**

On 17th February 2018 at around 2000hrs, I was driving my vehicle bearing registration number SGJ1320J along Thomson Road and was making a left turn into a slip road towards Norfolk Road. I noticed that there was a vehicle in front of me bearing registration number SLP406P making the same turn as well. Suddenly, the said vehicle braked suddenly and I could not avoid his vehicle on time, and I hit onto the rear bumper of the said vehicle. The impact of the accident was minimal as I was travelling at about 40km/h.

After stopping my vehicle, I alighted to make a check on the other vehicle's driver and also check on my vehicle condition. I noticed that there were no major damages to my vehicle, only for some scratches and I am not sure if the said scratches was a result of the accident. The other vehicle also had some minor scratches. The driver of the other vehicle, a male Indian subject, appears to have no visible injuries and looked tired, however I did offer to call for an ambulance or Police assistance which he rejected at first. A few minutes later, a friend of the said driver arrived at the scene and the driver informed that he has a headache at the back of his head, and requested for ambulance. As such, I called for Police assistance and requested for ambulance as well. I would like to add that the said driver looked fine and was not walking in an unsteady manner.

Ambulance arrived thereafter and the said driver was conveyed to hospital. I was then attended by two Traffic Police officers and was instructed by them to lodge a Traffic accident report immediately. That is all.

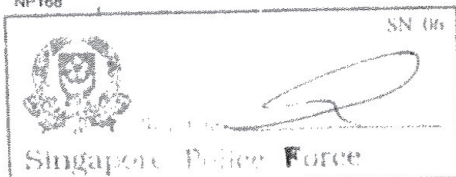


