I refer to my email on 22 May, 2015 (please refer the copy below for your reference), and our telephone conversation earlier today.

At your request enclosed is the images of the damages for both vehicles taken at the accident scene by myself for your reference. I refer to the abovementioned matter and our telephone conversation this morning.

On 24 April, 2015, I went to Borneo Motors (an authorized workshop) to report on the accident for a Third Party Claim and Mr. Patrick has attended to my case.
