According to our surveyor, there could be some misunderstanding here.

The "damage" to the fender that you are referring to, is it the grazed mark?

The grazed mark to the fender is probably some damages that the owner incurred during some other unrelated accident.

The "damage" I am referring to, is the bloated portion of the fender which was buckled outwards due to the excessive force experienced during the frontal impact.

The impact force permeates toward the front RH fender and forces a separation between the fender and the inner structure which was highlighted in the previous illustration.

Hope that the above clarifies matters.
