I turned back to make a check and I saw a van driving past with a police car behind it with siren on seemingly giving chase of the van. The police car vehicle looks like a Landover type. The van and the police car both turned right into Tampines st 91 and disappeared. I also made my way into Tampines st 91 and I turned into the carpark of Blk 929 Tampines st 91 to check on my vehicle.

My vehicle's left rear light is broken. The whole of my car's left rear side is badly damaged.

I was not able to catch the van's and the police car's registration plate as it happened too quickly.

I do have a in car camera working facing forward in my car. I am not injured.
