Blue Car SMK6929U White Car SLH4305K Both me (SMK6929U) and the 3rd party vehicle (SLH4305K) was driving on the middle lane of Tampines Ave 5. SLH4305K was in front of me. I wanted to cut in to left lane so that i could be able to turn to left into Tampines Ave 4. There is a stopped car on left lane which was blocking me from doing so. So i kept driving on middle lane trying to take over the stopped car on left lane. SLH4305K still in front of me but driving slowly so i thought he could be wanted to turn in to Tampines Ave 4 and he was also waiting for the chance to cut in to left lane. Suddenly the stopped car on the left lane started moving. We both slowed down the speed to let the car goes further so that we could cut in to left lane.
