Brief Details.

Due to the hit, my bike wobbled. While I was trying to control my motorcycle, the said taxi hit onto the end of my motorcycle left handle. Due to this hit, me and my pillion had fell together with the motorcycle. Ambulance and Traffic Police came down. Myself and my pillion were convey to NUH. I was warded and discharged on 04/04/2020.
