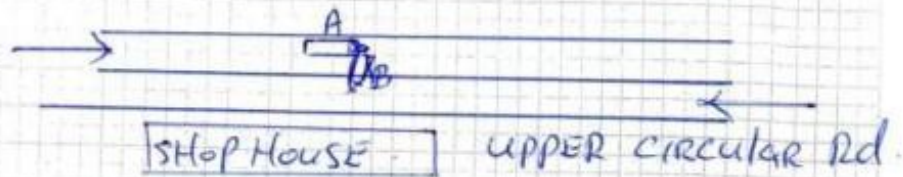

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 20/04/20 AT AROUND 1316HRS, I WAS DRIVING SJV8070K ALONG UPPER CIRCULAR ROAD. I REALIZED THAT MY VEHICLE WAS OVERHEATING. I THEN STOPPED MY VEHICLE ALONG THE ROAD SIDE AND WENT TO THE NEARBY SHOP (SONG FA) TO TAKE SOME WATER AND TOP UP. AS I WAS ABOUT TO GET BACK TO MY CAR, I SAW VEHICLE NO SJU 7098T WAS REVERSING AND HIT MY VEHICLE. HE THEN GET OUT OF HIS CAR AND ADMITTED THAT HE REVERSED AND ACCIDENTALLY HIT MY VEHICLE. HE CALL FOR A PRIVATE SETTLEMENT AND WE EXCHANGE CONTACT DETAILS. AT AROUND 2313HRS HE TEXT ME TO INFORM ME TO SEND MY CAR FOR DAMAGE ASSESSMENT. ON 21/04 I SEND HIM THE ASSESSMENT. HOWEVER HE INFORM ME TO CLAIM INSURANCE. DAMAGE TO MY VEHICLE: FRONT RIGHT FENDERS AND BUMPER. I ATTACHED ALSO A LETTER WRITTEN BY HIM THAT HE REVERSE AND HIT ON MY VEHICLE, WITH NAME AND HIS MOBILE NUMBER.
