**Circumstances of Accident**

MY VEHICLE STOPPED WITH A STATIONARY POSITION AT JALAN BUKIT MERAH TOWARDS HENDERSON ROAD AT CENTER LANE OF 3 LANES AS TRAFFIC WAS RED. AFTER THE TRAFFIC LIGHT TURNED GREEN, THE VEHICLE IN FRONT OF ME STARTED TO MOVE AND I FOLLOWED SUIT. SUDDENLY, I FELT A HUGE IMPACT. I ALIGHTED AND REALISED THAT VEHICLE B COLLIDED ONTO THE REAR RH PORTION OF MY VEHICLE AND CAUSED DAMAGES WHEREBY THE RIDER FELL ON THE FLOOR. I WALKED OVER TO LIFT THE VEHICLE B AND OTHER ROAD USER HELPED TO CALL AMBULANCE. AMBULANCE AND TRAFFIC POLICE ATTENDED THE SCENE. TRAFFIC POLICE TAKE DOWN THE PARTICULARS AND GET BOTH OF US TO MAKE REPORT TO OWN INSURANCE. VEHICLE B REFUSED TO BE CONVEYED BY AMBULANCE TO HOSPITAL. AFTER THE ACCIDENT, I FELT PAIN ON MY NECK AND SHOULDER.



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

My vehicle stopped with a stationary position at Jalan Bukit Merah towards Henderson Road at center lane of 3 lanes as traffic was red.

I alighted and realized that veh B collided onto the rear RH portion of my vehicle and caused damages whereby the rider fell on the floor.

I walked over to lift the vehicle "B" and other road users helped to call the ambulance.

Ambulance and traffic police attended the scene. Traffic police take down the particulars and get both of us to make the report to our insurance.

Veh B refused to be conveyed by ambulance to hospital. After the accident, I felt pain on my neck and shoulder.
