We are of the opinion that the video shows slight contact between both vehicles at the 8sec to 9 sec mark of the video for the front facing camera.

Based on the above, we are of the view that Insured driver had cut into Third party's lane and there was slight contact with Third party vehicle which resulted in third party vehicle to hit the road kerb.
