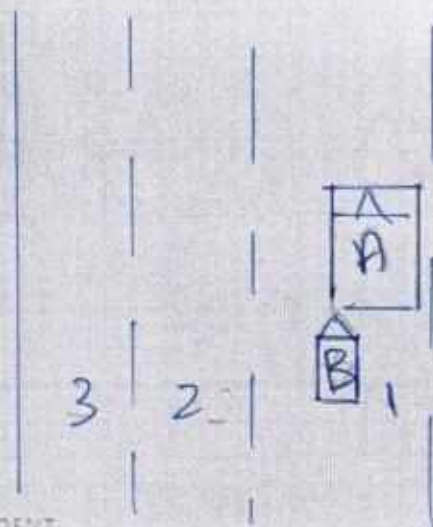

SKETCH PLAN

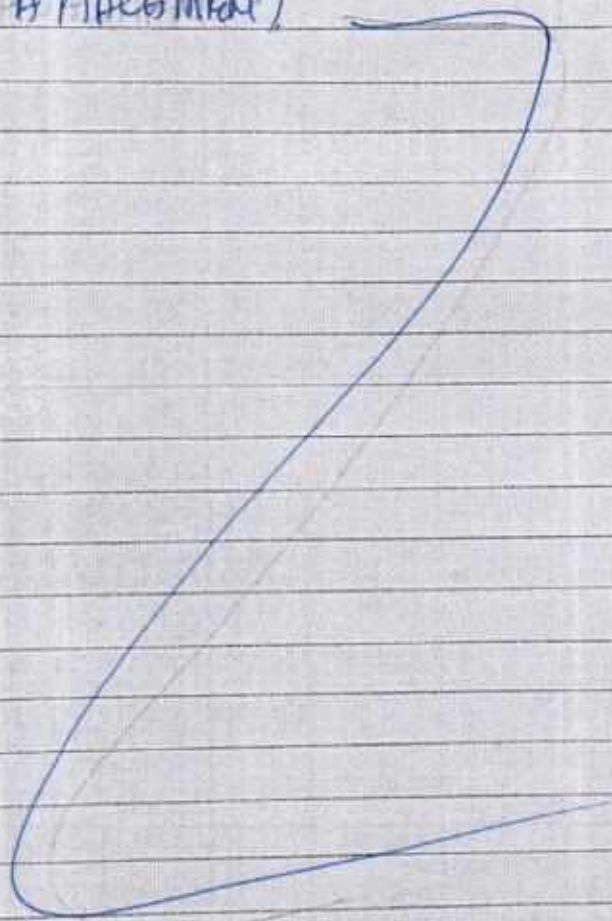
Along BRADFIELD ROAD TOWARDS BILHAM JUNCTION

AT 16:30 hrs

On 26th Mar 2020, while I was driving on Braddell Road outside the entrance of Majlis Ugama Islam Singapura building, I heard a knock on the rear corner of the van (GW4272X). I was on lane one preparing to right turn at the junction of Bishan Road traveling at around 50-60 km/h. Traffic was sparse and the weather was quite sunny.

After being hit, I saw a motorcycle FBG2630H (Yamaha FZ16) riding towards the side of the road. The rider was Yee Jia Cheng (S9672434I), there was no pillion rider. We have both stopped and I noticed that the rider appeared to be well and with no sign of injury except minor abrasion on the right foot. I attended to his fifth digit with some water, and provided clean tissue although the bleeding has stopped.

There was no visible damage to the bike, but there was a rather long straight and horizontal scratch line of more than 1.74 metres on the paintwork of the van starting from the rear corner.

The rider video chatted with someone on the phone. About 5 minutes later, 2 cars, SKC2104A and SJR9792G pulled in which have an older man with 2 other of his helpers. They appeared to be very proficient and experienced in car accidents with contacts of a few nearby clinics, bike tow truck and etc. All arrangements were made within minutes and the rider took the man's car and the man's helper attended to the bike while waiting for their tow truck.

The young rider, Yee Jia Cheng, who has newly received the licence on the 6th Aug 2019, was unable to control the power of the bike due his relative inexperience. His excessive speed on that the road and misjudgement of this to be an expressway could have caused the accident.

As the van is on long term rental, there is burden of non-usage, workshop repair, much critical time has been lost and including unable to fulfill customer requests and so forth.

(b) Any other person who is driving on the Policyholder's order or with his/her permission.
