On 26 January 2020 (Sunday) at about 5.39 am., motor taxi SH7204R was travelling along Sims Way and entering the slip road into Sims Avenue collided onto an 83 year old pedestrian who was crossing from the taxi's left to right. The pedestrian was sent to TTSH and on 27 January 2020 he was pronounced dead.
