Circumstances of Accident

ON 27/04/2020 AT ABOUT 1030 HRS, I WAS DRIVING MY VEHICLE, SMM560C AND HAD ENTERED THE CAR PARK OF BLK 448 PASIR RIS DR 6 OPEN CAR PARK. I DROVE FORWARD AND STOPPED AT THE STOP LINE. I SAW THERE WAS A RED TRASCAB TAXI, SHD258H, IN LOT 193 WHICH WAS OPPOSITE TO WHERE I AM. THERE WAS A MALE CHINESE DRIVER IN THE TAXI AND HE WAS DOING NOTHING. AS THERE WAS NO VEHICLE PASSING BY, I MAKE A RIGHT TURN. AT THAT MOMENT, THE TAXI SUDDENLY ACCELERATED OUT OF HIS LOT AT A FAST MANNER AND AS A RESULT HIS VEHICLE COLLIDED ONTO THE FRONT OF MY CAR. THE COLLISION RESULTED IN DAMAGES TO BOTH OF OUR VEHICLES. THE FRONT OF MY VEHICLE WAS DAMAGED. WE ALIGHTED AND TOOK PHOTOS OF THE ACCIDENT. HE ONLY GAVE ME HIS CONTACT NUMBER (HP:90225998) . I HAVE WENT TO MY RENTAL COMPANY TO REPORT ON THE MATTER AND LODGING THIS REPORT AS INFORMED BY THEM.

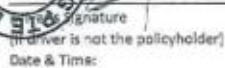

Brief Details.
