## Brief Details.

I was driving back from CNB HQ on the SLE(extreme right lane) and after passing the junction with Upper Thomson Road, there was a right bend ahead. I accidentally over steered and end up grazing the right side of the vehicle against the central divider for about 2 seconds before i steered the car straight.
