Brief details.

I am making this police report both in my personal capacity and for and on behalf of my father, Mr Leow See Keow (NRIC No. S0053686E).

My father is a taxi driver of vehicle SHD 9176B (the "Taxi"). On 28 April 2020, at about 3.10pm, my father was driving the Taxi towards Changi Road after making a right turn from Chai Chee Drive. The Taxi was on the first lane, and my father stayed on the same lane throughout in his direction towards Changi Road. This same lane the Taxi was on later became the second lane when the Taxi passed around 671-673

Changi Road.

Suddenly at or about 3.11pm, some distance before Siglap View (right outside Esso Changi located at 649 Changi Road), a black vehicle of vehicle plate number SLL 9517L (the "Black Honda") which was on the third lane suddenly swerved to his right, into the lane the Taxi was on (the second lane), colliding into the Taxi. My father tried to avoid the Black Honda's sudden right swerve, but was unsuccessful. The impact coupled with my father's attempt to avoid the collision eventually caused the Taxi to stop at the first lane, with the Black Honda stopping at the second lane. During this incident, my father hit the steering wheel which later caused him some breathing difficulty and chest pain. The driver of the Black Honda (the "Defendant") later apologised to my father.

Shortly after, my father informed the family about the incident. Soon after, I joined my father at the scene.

When I arrived at the scene, I immediately took photographs of both the Taxi and the Black Honda post-collision. I also exchanged my father's particulars with the Defendant's, whom I later identify to be one Eu Chee Lun (Yu Zhilun), male (NRIC No. S82099711). I also called Transcab's towing services as the Taxi was badly damaged. After exchanging personal particulars and contact details, the Defendant left when his vehicle was towed away. After the Taxi was towed away, I brought my father to Accident and Emergency department of Changi General Hospital as my father was still experiencing chest pain and breathing difficulties. My father was later given 4 days outpatient sick leave.
