Brief Details.

On 28/04/2020, at about 1740hrs, I was in my car along Yishun Central on the extreme right lane and was about to make a right turn into Yishun Central 1. My car was stationary on the right-turn lane while waiting to make the right turn when traffic permitted. There was one car directly in front of me in the right-turn pocket who was also stationary and waiting to make the same right turn.

Suddenly, my car was hit very hard from directly behind me with such a great impact that it caused my car to surge forward and hit the aforementioned car in front of me. No ambulance came to the scene but I felt tremendous pain due to the whiplash from the impact, and went to the doctor shortly after where she told me to go for an x-ray if pain persist.
