Brief Details.

On 04.02.2016, at about 1518hrs, I was driving my taxi (SHD9209R) travelling on Commonwealth Drive which is a two way road and there is a double white line to divide the lanes. Around the vicinity of Blk 92, I felt a bang onto the left side of my vehicle and I immediately stopped and check. There was an orange Subaru (SGV611M) that is positioned half way up of the road pavement beside Blk 92. I notice the orange Subaru side bumper was severely damaged and my left head bumper have been dented in due to the collision. After that, I went to check on him and we both agreed on moving to the car park opposite to discussed about the claims. Owner of Subaru is a male Malay believed to be around age 30 and he told me that it was not necessary to exchange particular, so I only took down his vehicle reg no. During that point of time, I did not felt any pain as I was all focus on the accident. Upon moving out, I realize I could not turn to the left due to the metal blockage caused by the bumper metal dented in.

On 05.02.2016, at about 0600, I woke up and felt a strain on my back neck area and headache so I went to see a doctor at Mount Alvernia hospital. I was given 5days of medical leave from 05.02.2016 to 09.02.2016. I noticed there was camera station around the area where the accident happened. I did not take pictures of the incident as I was only using a Nokia phone.
