

at 10km point <sup>bredell highway</sup>


On 28/04/2020 9.50am, I was driving along CTE towards North  
 Heard screeching & felt my car being hit from behind  
 Slowed down and was about to alight when felt  
 another bang from behind, a 3rd car hit our cars.  
 Felt strain on neck and back and slowly walked out  
 to investigate. Saw 2nd driver bleeding as he moved out  
 of his seat, and he was on the phone. The 3rd driver  
 was ok and taking pictures. I proceeded to take pictures  
 of the 2 cars and damages. Suddenly another car  
 rammed into the 2nd car, making a 4 car chain.  
 A <sup>off duty</sup> policeman stopped to assist and he called for  
 ambulance and TP.

The 2nd driver was stretched off into the ambulance  
 as the TP made their reports. After ID and many  
 parties did their work, the tow trucks towed us off  
 the cte to a nearby camp along Arnt Ave 1  
 Bredell. As there were injuries, the cars are  
 impounded by the police.


The next day I went to TP HQ for ID meet
