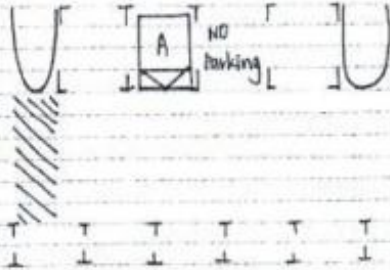
## Accident Sketch Plan
