Brief Details.

On 07/05/2020 @1540hrs, I was driving my car (SLD7019M) along Ang Mo Kio Ave 3 towards Hougang Ave 2 and I was travelling on the extreme right lane. I then stopped my car at the traffic light junction of AMK Ave 3 and AMK Ind Park 2 cause of 'RED' light. Suddenly I felt an impact coming from the rear of my vehicle. I then alighted to make a checked and discovered that a m/van (GT4598C) had collided onto the rear of my car. As there was no one injured in the accident at that point in time, we exchanged particulars and left the location. Later in the day I felt pain on my neck nd back of body. I then seek treatment at Lifelink 24 Hours Clinic at Serangoon North Ave 1 and was given 2 days medical leave. On 09/05/2020, as the pain continue to persist, I went back to the clinic to seek further treatment and was given a further 2 days medical leave from 10 - 11 May 2020. My car was slightly damaged in the accident.
