CONTINUATION OF REPORT

Brief Details.

On 08/05/2020 at about 0815hrs I was driving along Alexandra road before Gillman barracks. I was on the middle lane when I was driving along the bend at Alexandra road. While I was driving along the middle lane, my vehicle bearing registration plate number (YP620E) started to move towards the right lane without my control. I tried to control my vehicle and drive back towards the middle lane by turning my steering wheel slightly to the left, however my vehicle swerved all the way to the left lane. I was not able to control my vehicle and it hit onto the road kerb railing. There is a slight damage to the road kerb railing. My vehicle tipped over and landed on the left side of the vehicle.

The damages incurred to my vehicle is as follows:

- 1) The front portion of my vehicle is totally damage.
- 2) The left side of my vehicle is also damaged.
- 3) My steering wheel is also jammed.
