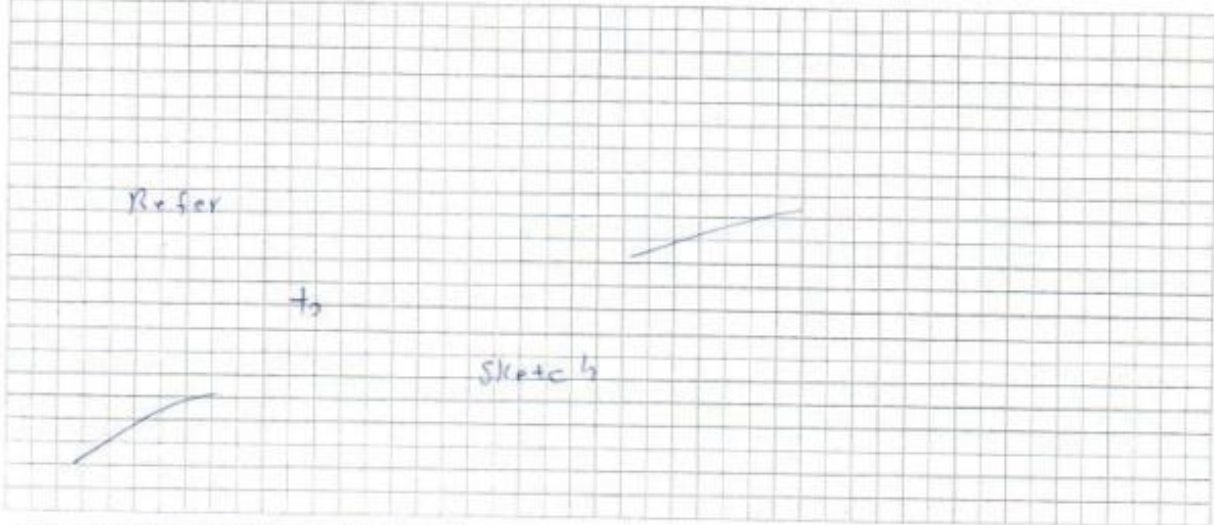

SKETCH PLAN





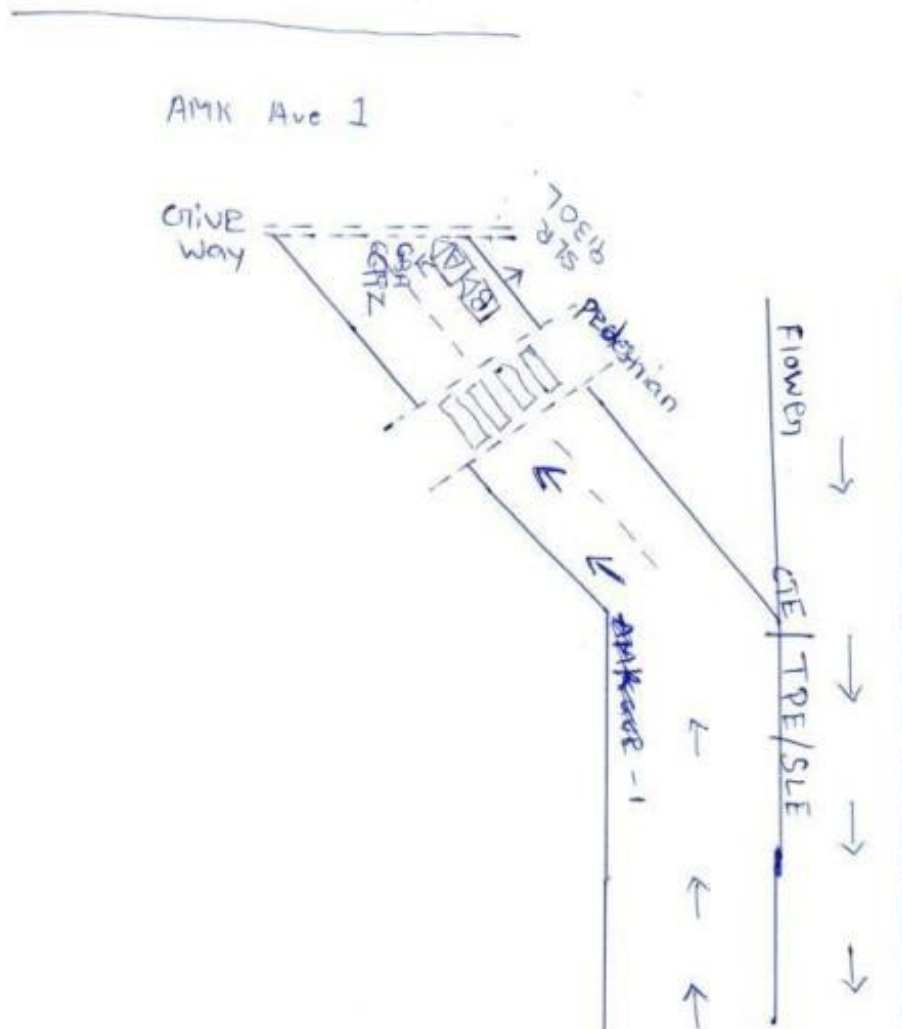
