

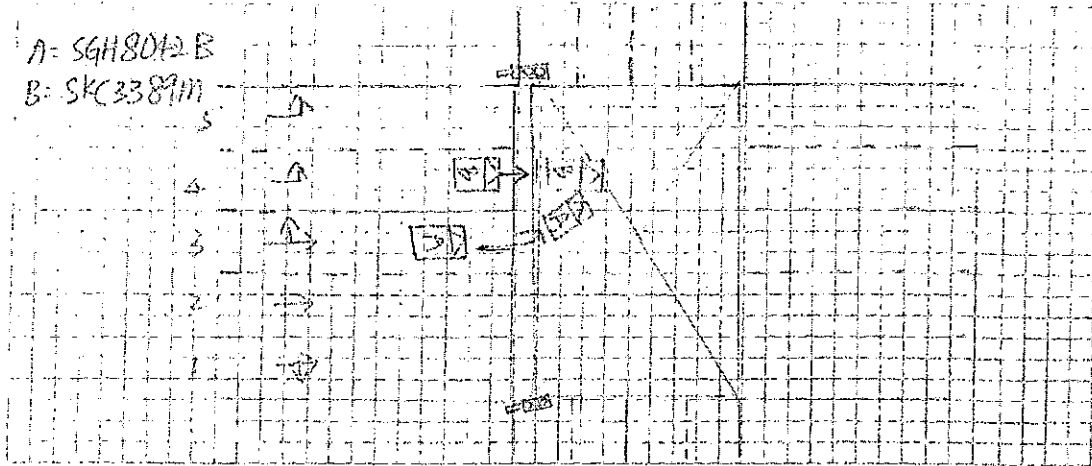

Brief Details.

My name is Law Chee Wai Danny, S8852189G, car plate number SGH8042B.
Today on 5th May 2020, at the junction of Marina Boulevard, I was the victim of a hit and run.
I was the 3rd car from the left, about to turn left onto Sheares Ave. When the traffic light turned green, the car in front of me was also turning left.
I proceeded to turn left as well.
The car on my left (SKC3389M) drove straight instead of turning left on a TURN LEFT ONLY lane.
The driver hit the front left corner of my car (SGH8042B).
After the impact, the driver continued to drive forward along Marina Boulevard.
I horned at the driver. By then he already moved off from the yellow box and travelled straight.
I then drove my car behind him and he stopped his car on the left side of the road.
I got out of my car with the hazard light on and approach the driver.
He admitted that it was his mistake for going straight on a TURN LEFT ONLY lane.
We then exchanged particulars and have a verbal discussion about having a private settlement.
I took some photos of the car damages and left.
Afterwards, the brother of the driver called me and say that they will not admit it was their fault and ask me to file for a insurance claim and refuse to make good of the private settlement.
Sadly I do not have a car cam in the car. But I noticed a LTA surveillance camera at the particular junction.


