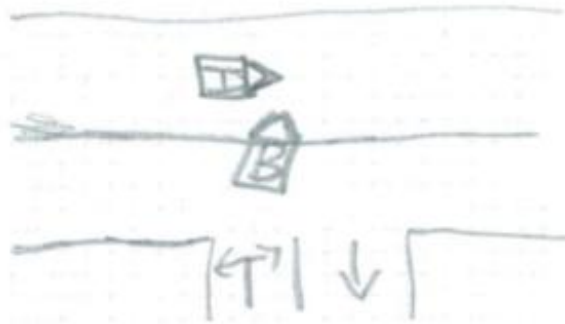


## Sketch Plan #2
