Further to the below matter.

We have spoken with OI company in-charged Mr Kishore and were informed that their counter claim against TP insurer have yet settle up to date.

We have requested Third Party to provide substantial evidence to support their claim. However, the claimant unable to provide any evidence.

Based on the circumstances of the accident and damage profile of both vehicles, we are of the opinion that TP vehicle hit onto our insured vehicle's rear right porting when his vehicle swerve to the right to avoid hitting OI vehicle while OI vehicle made a sudden break and resulted still hit onto OI vehicle rear right corner.

Since TP unable to provide substantial evidence to support their version, we are intending to reject TP claim.

Kindly advise your instruction/approval/comments if any.
