I CHECKED MY SIDE MIRRORS AND STARTED TO REVERSE. WHILE REVERSING, I HEARD HORN SOUND. I CHECKED MY REAR MIRROR AGAIN AND THERE WAS NO VEHICLE. SO I PROCEEDED TO REVERSE. THEN I FELT AN IMPACT. ALIGHTED AND REALISED, I WAS HIT ONTO VEHICLE SMC3286C WHICH WAS FROM MY LEFT REAR CORNER. VEHICLE B WAS AGAINST THE TRAFFIC FLOW. NOBODY WAS INJURED.

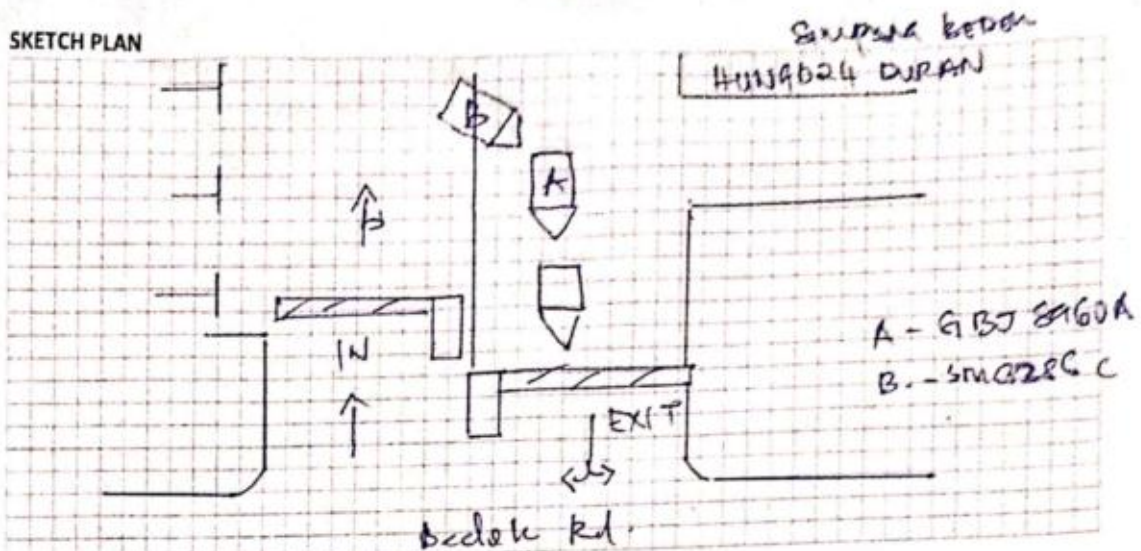

Aborting and realised, I was hit onto vehicle SMC 3286C which is from my left rear corner. Vehicle - B was against the traffic flow. Nobody was injured.

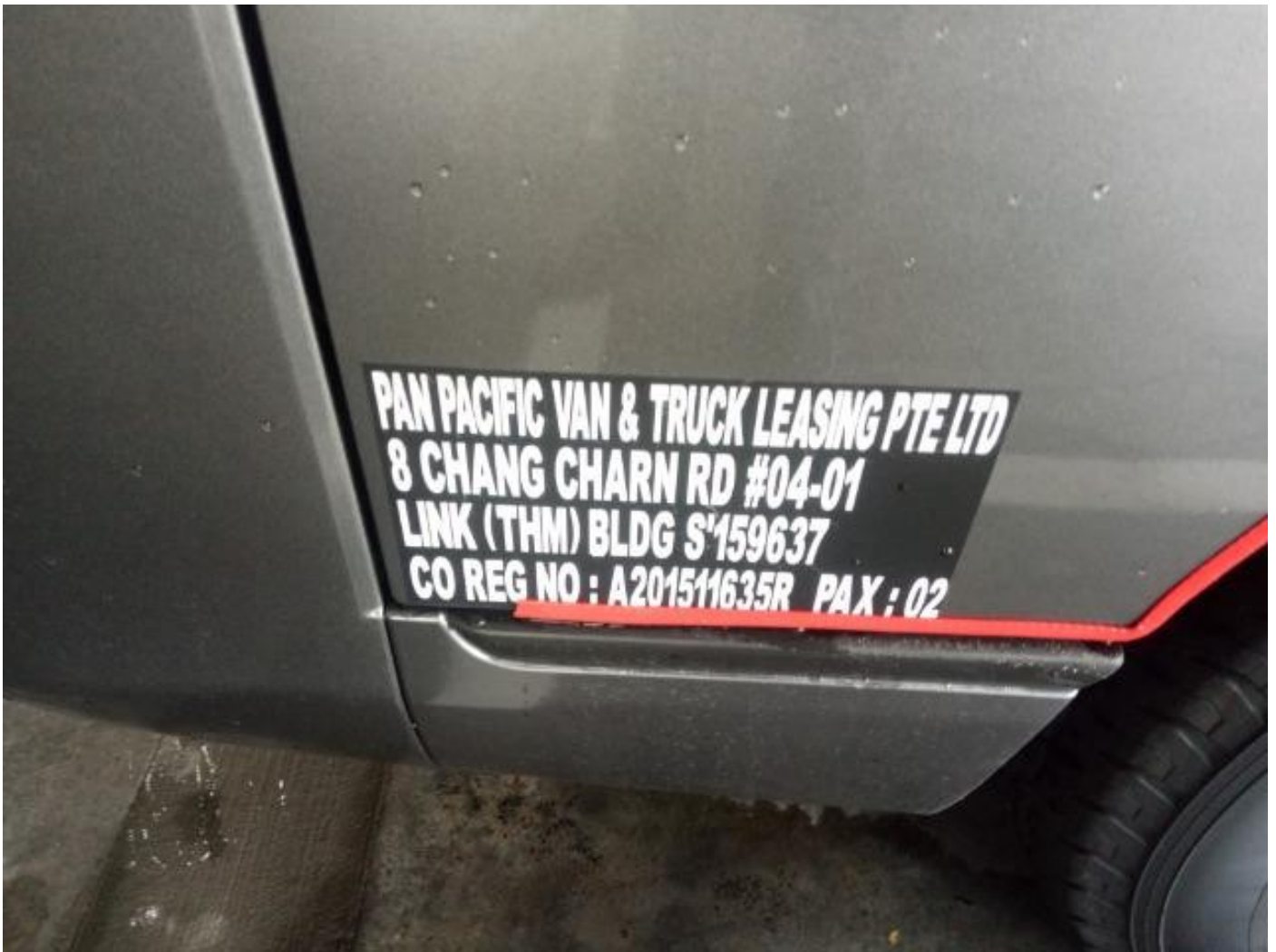

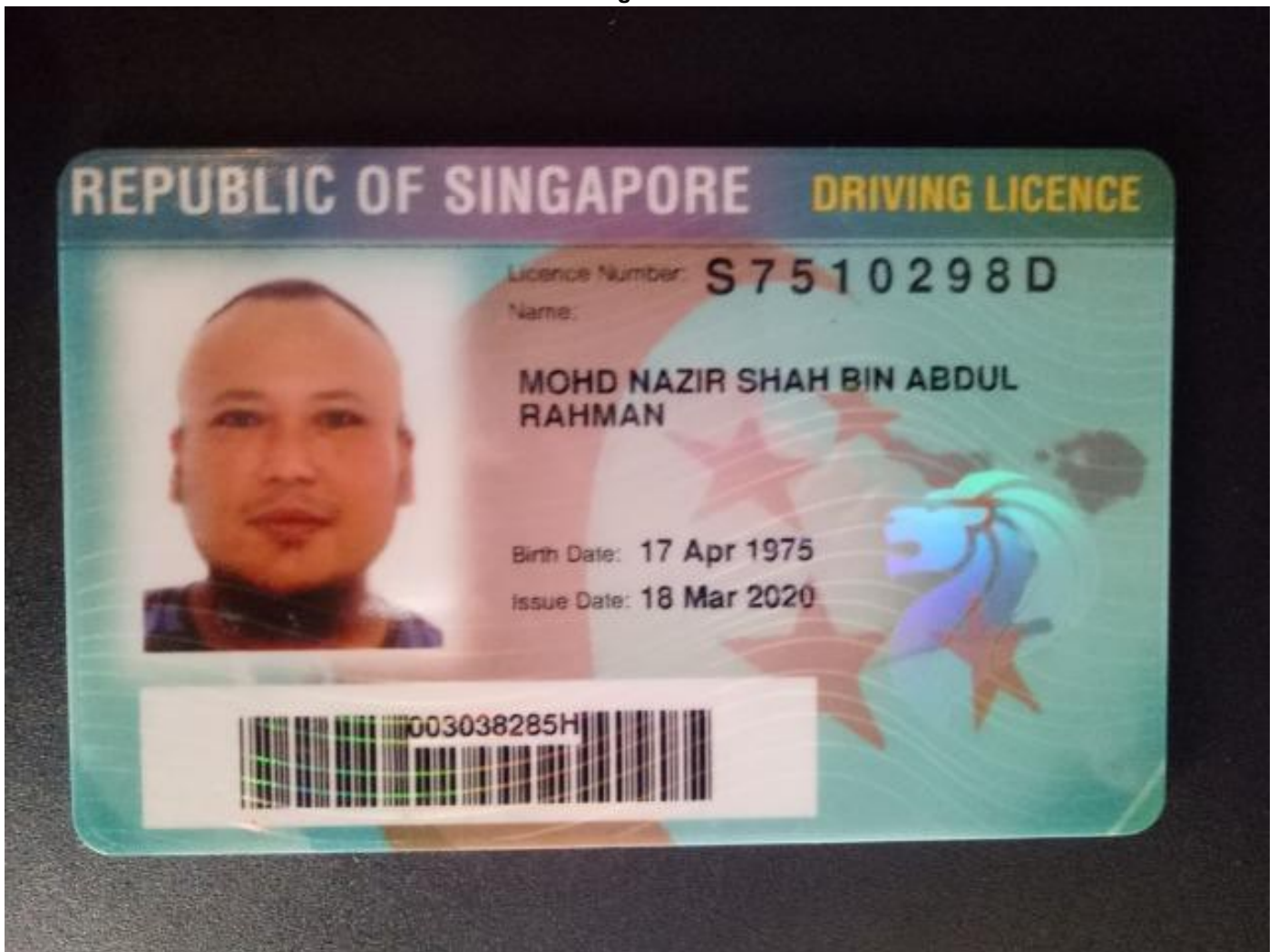
