



BK 925 Yishun Ctr



Describe Circumstances of the Accident

On 5/12/14 at 4.40pm, I was driving my vehicle SGG5290B (A) in the Yishun Central / BIK 925 carpark. This carpark was very steep. I was moving up a very steep slope. The car SJP7452E (B) was in front of me. This driver of SJP7452E turned right after waiting for carpark lot. completing the slope and stopped. So, I followed to stop behind. Note there is another vehicle at carpark lot no. 3 going to come out from his lot. Suddenly, the car SJP7452E (B) reversed very fast all the way and its RH rear bumper corner dragged all the way down my front portion, causing the whole front portion and number plate to be broken and dropped on the floor. Then, after the impact, the driver (B) SJP7452E moved forward again, causing his rear bumper to crack. At because, he noted he reversed as he wanted to park into the carpark lot 3 on his left side (see attached photos). No one was injured. We exchanged particulars. I'm lodging the report to claim from his insurance.


