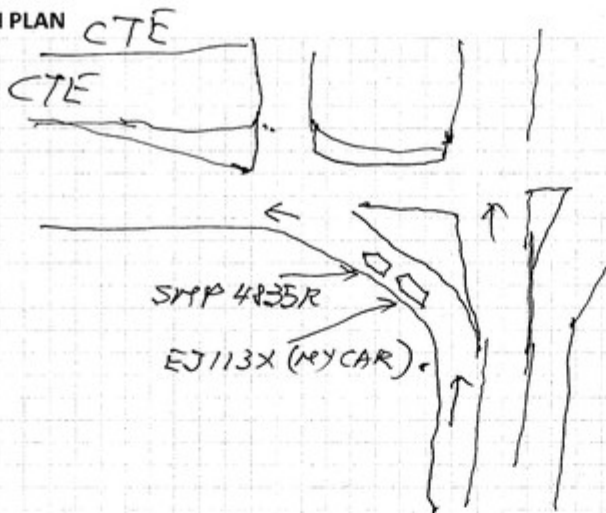

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling from Braddell Road to CTE (to SLE) at 5.45pm on 20th May, 2020.

As I was slowly filtering left from Braddell Road into CTE (to SLE) and was driving onto the slip road, I saw the car in front of me, SMP 4853R, had no brake light and I thought it was a moving car.

Then I realized that it was not moving and I immediately braked, but was too late and I accidentally but gently hit onto its back, causing a tiny dent on his back white top bumper that is almost not visible and a slight knock on its black lower bumper, which was also not very clearly visible. The damage was very negligible. The driver of SMP 4853R was Mr Lim NRIC ending 0650, hp 91234451.

There was only a slight dent to my car plate at the front. There were no physical injury to Mr Lim, myself and my passenger who is my wife.

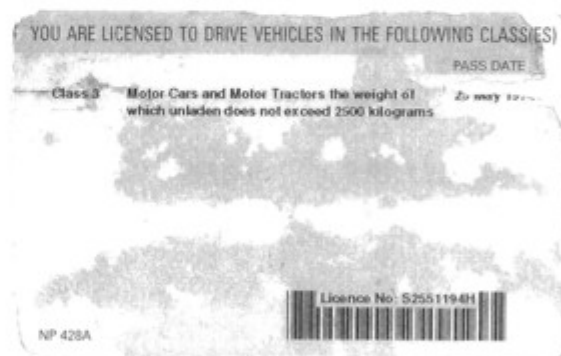

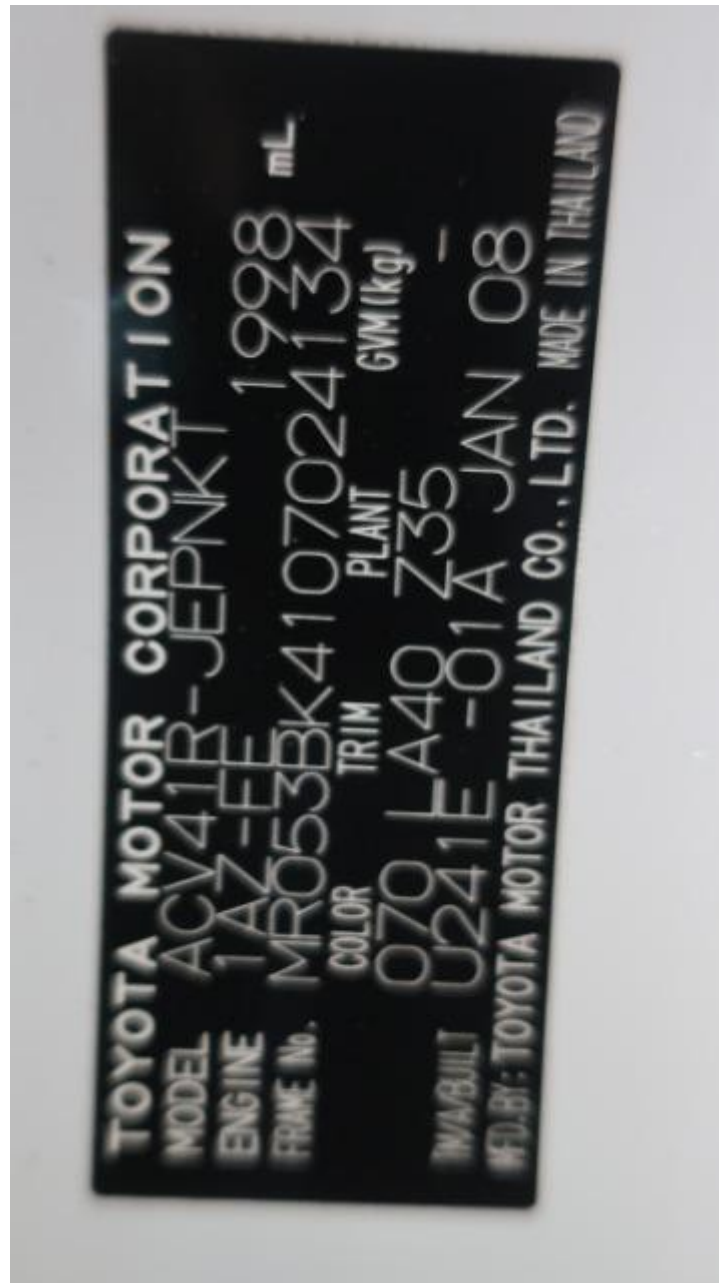
