Brief Details.

On 19/12/2017 at around 1230hrs, i was travelling along Telok Paku Road near Blk 1A Mechanised Car park. While travelling, I signaled and was about to turn right into the car park. However, the vehicle behind me, bearing registration plate number, SJZ5740J, did not see my signal and me coming to a stop. As he did not see my vehicle coming to a stop, the right front side of his vehicle collided onto my left back side of the vehicle I was driving.

We got down our vehicle and exchanged our particulars and as no one was injured and it was a minor accident, we did not call for police or ambulance.

The damages to my car are as follows:

- 1) Scratches and dents at the left back side of my vehicle,
- 2) Rear left bumper came out.

The damages to the other car are as follows:

- 1) Scratches on his right front side of his vehicle,
- 2) Broken left front headlight.
