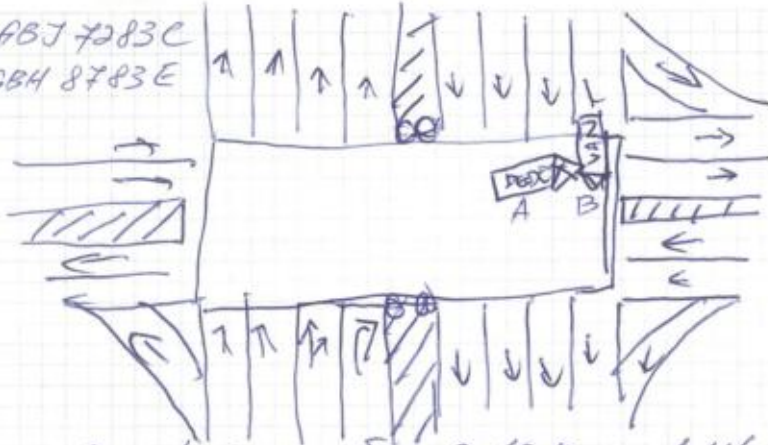

Accident Description: On May 22 at approximately 10:23hrs, crr was driving vehicle GBJ7283C and approaching the intersection to make a right turn to Kaki Bukit Ave 1. He observed that the traffic light was green. Upon checking and confirming that there were no cars driving straight in lanes 1 to 3, and the only vehicles moving off were to make a left turn to Kaki Bukit Ave 1, crr proceeded to inch forward to complete his right turn. However, half-way through his turn, he noticed a van speeding towards his direction, and even though he applied a jam brake, it was too late. His van had already collided with the van at the intersection.
