CONTINUATION OF REPORT

Brief Details.

On 26/05/2020 at about 0750hrs, I was driving a white bus bearing the license plate CB8099 along Jurong West Ave 2. While travelling along Jurong West Ave 2, there was one red in colour taxi bearing the license plate SHF591J turning into Corporation Road. The Traffic Light was green and I was driving in that direction. Suddenly, the red taxi turn and hit onto my bus.

After collision, I told my passenger to call for ambulance as I saw that she was slightly injured. Police and ambulance later then arrived.

The impact of the collision injured one of my passenger and the passenger was conveyed to hospital.

Police officer provided me with a case card stating the report no. J/20200526/0053 with the investigation officer Ivan, contact no 65476170. Police officer also took my in-vehicle camera's SD card and I was given an acknowledgement slip. I wish to add that I experiencing some pain at my head and neck region and wish to further state that my vehicle's right side was damaged.
