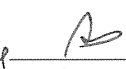

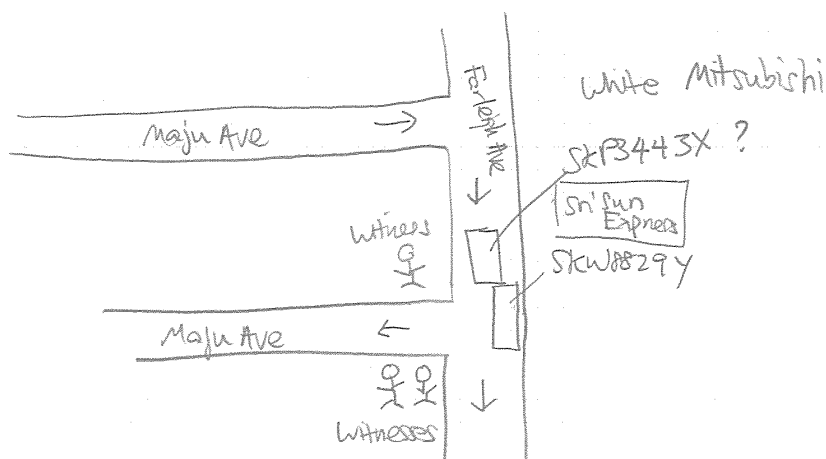

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

As there was a car, I stopped and did not move my car. To my surprise, the car did not see me stop and hit my car at the back on the right side. There was a sound of the bump. I got out of my car to exchange details but the car quickly sped off down Maju Ave very fast. I think the driver was trying to escape. As my phone was in the car, I did not manage to take photo of the escaping car plate number but saw that it was a white Mitsubishi with complete SKP3443X.
There were also other witnesses (passer-bys) who saw the accident KT - 96364744 and Andre - 90662316, who are willing to share their account. Additionally, I was not intoxicated during the accident (only one drink the entire night)
