Brief Details.

On 24/10/2018 at 1120hrs, I was driving a government registered vehicle bearing registration number SLL9173U along Boon Lay Avenue. There were 2 other colleagues with me. I was approaching the junction of Boon Lay Avenue and Corporation Road and subsequently made a complete stop upon reaching the T-Junction of Boon Lay Avenue and Corporation Road as I gave way to oncoming cars along Corporation Road. A few seconds later, I felt an impact at the rear of the vehicle. My vehicle also lunged forward resulting from the impact. I then alighted to make a check and discovered a vehicle bearing registration number SLS7598D had hit on to the car's rear bumper. The vehicle's rear bumper was badly dented as a result of the accident. I then informed the driver that he was involved in an accident with a government registered car and advised him to lodge a police report. The driver acknowledged. As my passengers and I were injured from the accident, we seek treatment at Khoo Teck Puat Hospital. I was discharged and given 2 days of MC while my colleague Shazana who was seated
