Brief Details.

On 26/04/2017 at about 1025hrs, I was driving my taxi (SHD1168C) along Tanjong Pagar Road and I stopped at the T junction of Tanjong Pagar Rd and Keppel Rd. Keppel Rd is a five lane road. There is a yellow box for the first 3 lanes from the left. I did a check and after checking for clearance, I proceeded to make the turn to the 3rd lane (Middle Lane). When I was at the 3rd lane, I attempted to change lane again to the 4th lane (4th lane from the left), and I am not sure if there was no yellow box there for the 4th and 5th lane. I was unable to make a full check for traffic on the 4th lane as my view was blocked by the vehicles on the road.

As I am changing my lane from the 3rd lane to the 4th lane, I suddenly felt an impact from my right. I then realized that an oncoming vehicle (SJY2358E), that was travelling on the 4th of Keppel Rd, had collided onto the right portion of my taxi. We then moved our vehicles to the 5th lane (Most right lane) and alighted to assess our injuries and damages to our vehicles.

I observed that my taxi was dented in on the right front portion. The other vehicle's front left bumper is dislodged. However both of us were not injured. I had a passenger at that time and he was also not injured. There was no passengers on the other vehicle. We then exchanged particulars and left the incident area after 10mins. During the exchanging of particulars, the driver of the other vehicle informed that he is a Police officer and that the car is a police issued vehicle, but there was no police logo printed on the vehicle.

I will like to state that I had lost the particulars of the driver as I had forgotten to save the information inside my phone, after typing it down on my phone. It was a careless mistake. I had already reported this accident to my taxi company and they informed me to lodge a police report as well since a police issued vehicle was involved.
