Brief Details.

On 8 Nov 2019, I was the driver of a CNB operational motorcar QX 894J. I was alone. I left CNB HQ to proceed to Seletar Country Club to meet a witness for official matters.

I drove along Jln Bukit Merah & turn right into CTE AMK. Just as I was about to pass Exit 1B, I saw a pile up of vehicles in front of me. I saw that the vehicle in front of me (GBJ1872S) had already stopped. I applied my brakes but the operational motorcar skidded slightly forward before coming to a stop. The operational motorcar also gave the front vehicle a slight push to its rear bumper.

I alighted and saw that there were another 3 vehicles infront, involved in an accident. I walked to the front of GBJ1872S and saw that there was a gap between GBJ1872S and the vehicle infront of it. From there, I deduce that GBJ1872S was not involved in the accident involving those 3 other vehicles.

I saw that there was no visible damage to the rear of GBJ1872S. The operational motorcar had a slight bent to its front licence plate. There was also no injuries suffered by the driver and the passengers of GBJ1872S.

I gave my name and contact number to the driver of GBJ1872S and resumed my normal duties.
